The primary sources in this collection come from multiple regions, offering the opportunity for a comparative global study of left-wing thinking. For example, researchers can unearth how communist parties differ worldwide, why communism or socialism succeeds in some countries and not others, and the characteristics of these movements in different countries. The third collection in the *Political Extremism and Radicalism* series provides insight into how these groups saw themselves and the world around them during the major political and social events that occurred in the twentieth century.



ARCHIVES OF SEXUALITY AND GENDER: COMMUNITY AND IDENTITY IN NORTH AMERICA

This collection of twentieth-century primary sources explores society, sexual identity, community building, and gender issues through materials gathered from libraries and archives in Canada, the United States, and Mexico. In addition to highlighting the role of community groups and organisations in modern LGBTQ+ history, the archive sheds light on other areas of gender and sexuality, such as alternative sexualities, gender equality, sex and religion, disabilities, and race and ethnicity. The materials provide coverage of activism and social justice issues, highlight disabilities in queer society, and document diverse ethnic communities across North America. These collections also detail how identities developed in different social conditions and regions of North America and how communities grew around dedicated, often courageous individuals.





Established in 1891, federal appellate courts—called the United States Courts of Appeals—sit just below the United States Supreme Court, and whose documents are equally valuable records that provide trial history, depositions, transcripts, and arguments. As the 13th instalment in *The Making of Modern Law* and covering over 500 cases, this collection puts a concentrated focus on critical issues that continue to occupy the American social and political landscape, such as reproductive rights, gun ownership laws, incarceration and the rights of prisoners, environmental policy, and more, filling critical gaps in prior offerings on a case-by-case basis. This fundamental resource is a recommended addition to libraries already subscribing to *The Making of Modern Law*.

Disabilities in Society demonstrates how society has interacted with and treated individuals with disabilities historically. Materials include personal memoirs, records of treatments, methods of education, and forms of remediation. Included are reports and proceedings of organisations and institutions that sought to help or heal those with disabilities are included, as well as records of policies and programs. Through this collection, researchers will grasp the many forms of institutional discrimination, political exclusion, and social control against disabled individuals. This collection also documents the rise of disability movements and their efforts to gain political power. Materials chronicle how individuals were classified and treated and how some overcame physical or mental challenges to change perceptions of what it means to be disabled.

POWER TO THE PEOPLE!: COUNTERCULTURE, SOCIAL MOVEMENTS, AND THE ALTERNATIVE PRESS, 1960–2015

Power to the People! covers a range of ideas, initiatives, and social movements devoted to people-powered politics and organisations from the twentieth century. The archive ranges beyond a few specific campaigns, painting instead a broad picture of the counterculture and the many disparate organisations that represented this period in modern Western history. Although the archive concentrates mainly on those movements that operated in the United States and the United Kingdom, it also includes content that covers events and topics from around the globe. These primary sources document issues of social justice and how attitudes about civil rights, gender equality, the environment, the government, and many of society's institutions shifted dramatically to include citizen involvement, public welfare, and the planet's health.





ENVIRONMENTAL HISTORY: CONSERVATION AND PUBLIC POLICY IN AMERICA, 1870–1980

This diverse collection offers a glimpse into the many actors and agencies whose efforts shaped modern policy and legislation in conservation and environmental protection in the United States. Researchers will find the work of individual movers and shakers, such as early environmentalists George Bird Grinnell and "Father of Forestry" Joseph Trimble Rothrock, as well as later activists, like Rosalie Edge and Velma "Wild Horse Annie" Johnston. They can sift through a century's worth of agency records, such as the U.S. Forest Service, the U.S. Bureau of Reclamation, and the many departments focused on conservation and land-use matters, from water conservation to wildlife management, at both the state and municipal levels.
